Closing Dates - Entries will be accepted up to and including the start of the Match. However, all entries received after last post on Friday, 20th January 2012 will **NOT** attract the "Early Bird" discount and all entries received after last post on Friday, 3rd February 2012 will attract a fee of \$90.00 for all classes.

Payment - Entries must be accompanied by payment in full. Entry Forms will not be processed until payment has been received and cleared. Cheques should be made payable to **SSAA Wodonga - HGC**. EFT information can be made available on request to clc169@bigpond.com. WHGC reserves the right to charge an additional \$10.00 fee in the event of dishonoured cheques or refused authorisation of Credit Card payments for any reason.

Payment Periods – Entry Forms received after the stipulated cut-off dates that do not include the appropriate fee will be rejected and returned to the originator. Entry Forms will not be considered submitted until received with the correct fee.

Release and Waiver – In order to compete, all Entrants, without exception, will be required to sign the *Release and Waiver* at match registration.

Withdrawals - Withdrawals prior to or on 11 February 2012 will be eligible for a refund less an administration fee of \$10.00 per entry. Withdrawals after 11 February 2012 will be eligible for a refund less an administration fee of \$25.00 per entry. Failure to attend on the day will result in forfeiture of all fees unless deemed exceptional circumstances as adjudicated by the Executive of WHGC
